KNOW ALL MEN BY THESE PRESENTS, that the undersigned SOUTHERN ELECTRIC GENERATING COMPANY, a corporation, for and in consideration of the sum of Eighty four and 28/100 dollars (\$ 84.28) to it in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, does hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain electric transmission and communication lines and all towers, poles, conduits, conductors, cables, insulators, anchors, guy wires, counterpoise conductors, and all other appliances necessary or convenient in connection therewith, from time to time, over, under and across a strip of land one hundred twenty five (125) feet in width, as said strip is now located by the final location survey thereof heretofore made by said Company, over, under and across the lands of which it is hereinafter described as being a part, said survey to determine the boundaries of said strip, together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof for the purposes above described, including the right of ingress and egress to and from said strip and the right to cut, remove, or otherwise kill, and keep clear by any means, including chemicals, all trees and undergrowth and all other obstructions under, on or above said strip and danger trees adjacent thereto which now or may hereafter injure, endanger or interfere with any of the works on said strip and the right to install, maintain and use anchors and guy wires on land adjacent to said strip.

Said strip is a part of a tract of land situated in Shelby County, Alabama, described as follows:

Northwest Quarter of Northwest Quarter ($NW_{4}^{\frac{1}{4}}$ of $NW_{4}^{\frac{1}{4}}$) of Section 32, Township 20 South, Range 2 East.

To reach a point of beginning, commence at the Northwest corner of Section 32, Township 20 South, Range 2 East; thence run East along the north boundary line of such Section 32 a distance of 983.8 feet to a point on the north boundary line of the Grantor's property, such point being the point of beginning of the right of way herein described; therefrom, the strip lies 62.5 feet on each side of a center line and the continuations thereof which begins at such point of beginning and turns an angle to the right of 68 degrees 06 minutes and thence runs south 20 degrees 43 minutes East a distance of 61 feet, more or less, to a point on the east boundary line of the Grantor's property, such point being the point of ending of the right of way herein described.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns, forever, except as herein provided.

The grantor shall have the right to use said strip of land for any purpose not inconsistent with the rights which the grantee may from time to time exercise hereunder.

IN WITNESS WHEREOF, the said Southern Electric Generating Company has caused this instrument to be executed in its name by A. E. Burnett as its President, and attested by W. L. Sanders, Jr., its Secretary, and its corporate seal to be hereto affixed on this the 12th day of February 1973.
