KNOW ALL MEN BY THESE PRESENTS,

That in consideration of TWO THOUSAND, FOUR HUNDRED AND NO/100 DOLLARS

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,
Bernice Brothers Valentine, a single woman
(herein referred to as grantors) do grant, bargain, sell and convey unto

K. W. Schafner and wife, Judy Schafner
(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor
of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated
in Shelby County, Alabama to-wit:

From the SE corner of the NW¹/₄ of the NE¹/₄, Section 7, Township 21
South, Range 2 East, run west along the south boundary of said ¹/₄ ¹/₄
distance of 82.79 feet; thence right 79 deg. 39' a distance of 279.29
feet to the point of beginning; thence left 90 deg. 00' a distance
of 100.00 feet; thence left 90 deg. 00' a distance of 146.83 feet;
thence right 141deg. 05' a distance of 54.89 feet; thence right
24 deg. 50' a distance of 178.02 feet; thence left 30 deg. 05' a
distance of 31.45 feet; thence right 44 deg. 10' a distance of 395.00
feet; thence right 92 deg. 07' a distance of 174.98 feet; thence right
along an arc of 25 feet radius and through a delta angle of 87 deg.
53' a distance of 38.25 feet; thence continue a distance of 452.50
feet to the point of beginning.

There is also conveyed to grantee, his heirs, successors and assigns,
the right to use the present boat launching site of grantor on Lay Lake
for the purpose of launching boats for their private use, together with
the right to fish from the bank of Lay Lake on property now owned by
grantor.
