in hand paid by Triple L. Construction Company of Birmingham, Inc.

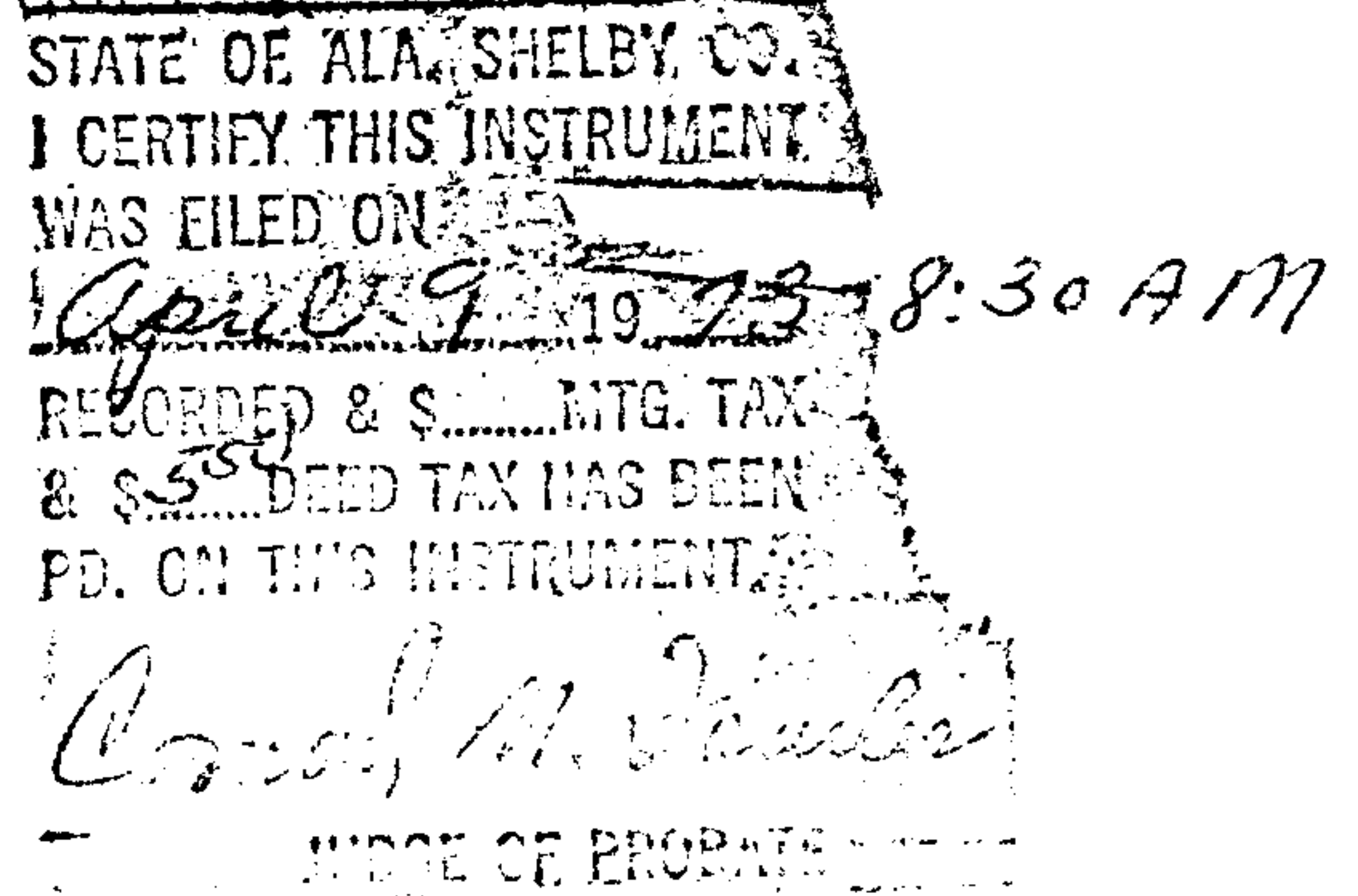
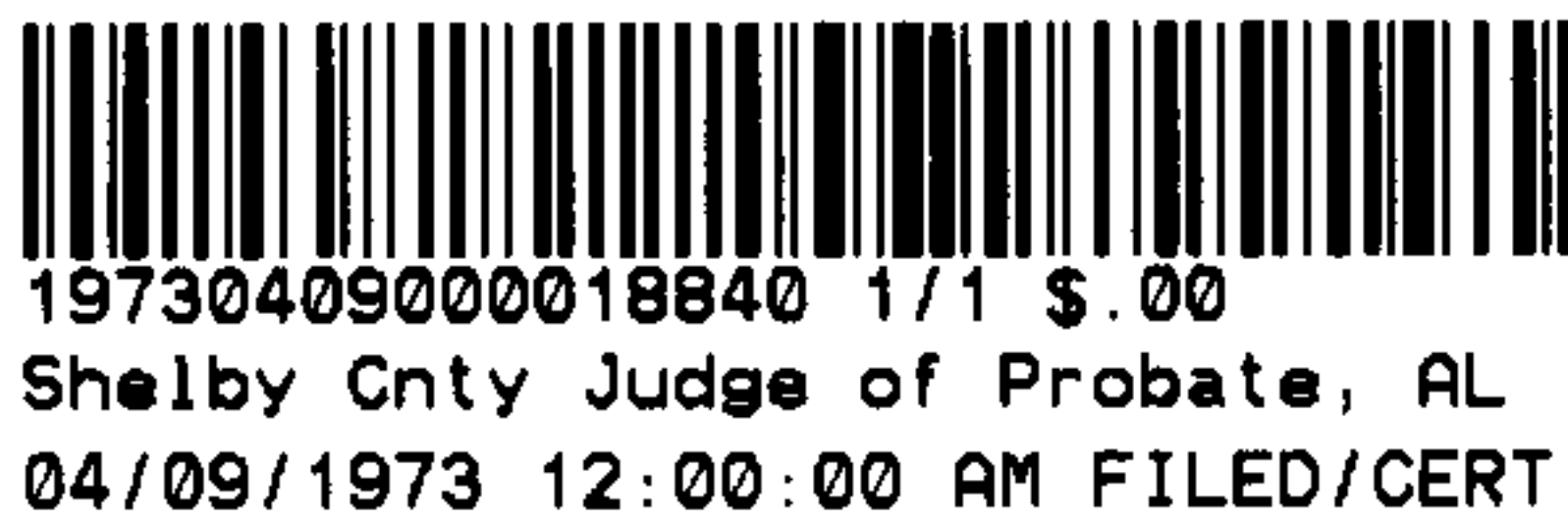
the receipt of which is hereby acknowledged, the said Cahaba Valley Homes, Inc.
