KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of Two Thousand Three Hundred Sixty and no/100 Dollars, to the undersigned grantors, Willie G. Messer, a widow; Homer Messer and wife. Flossie D. Messer, in hand paid by Lewis B. Walker, the receipt whereof is hereby acknowledged, we, the said grantors, do hereby grant, bargain, sell and convey unto the said Lewis B. Walker, all merchantable timber located on the following described property:

Begin at the Southwest corner of NE of NE, Section 8, Township 20 South, Range 1 East and run East 495 feet; thence North 1320 feet; thence West 495 feet; thence South 1320 feet to point of beginning. Containing 15 acres, more or less.

SET of NET, Section 8, Township 20 South, Range 1 East, except 6 acres South of Yellow Leaf Creek, and except 12 acres North of creek and off East side of SET of NET. Containing 22 acres, more or less. Situated in Shelby County, Alabama,

at any and all times for a period of three months from the date of this deed for the purpose of cutting and removing said timber, but after said time, grantee shall have no further rights or interest in said land or timber uncut and at the expiration of said time, said land and all uncut timber shall revert to the grantors herein.

And we do for ourselves and for our heirs, executors and administrators covenant with said Lewis B. Walker, his heirs and aggigns, that we are lawfully seized of said premises in fee simple; that it is free from all encumbrances and we have a good right to sell and convey said timber as

aforesaid; that we will and our heirs, executors, and administrators shall warrant and defend the same to the said Lewis B. Walker, his heirs and assigns against the lawful claims of all persons.
