### RIGHT-OF-WAY DEED FOR PUBLIC ROAD

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned,

\_\_\_\_\_ and wife \_\_\_\_\_ of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be \_\_\_\_\_ feet in width on \_\_\_\_\_ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a \_\_\_\_\_ foot right-of-way across our lands, said right-of-way herein conveyed being more particularity described as follows, to-wit: And as shown on the right-of-way map of Project No. \_\_\_\_\_ as recorded in the office of the Judge of Probate of Shelby County.

Commence at the Southwest corner of the SW $\frac{1}{4}$  of NE $\frac{1}{4}$ , Section 33, T-19S, R-1E and run North along the West boundary line of said quarter quarter section and crossing the center line of project CP4-159 at station 9+88.0 a distance of 284.0 feet to a point on the Northwest 40 foot Right of Way line of said project; thence run N 78° 39' E along said 40 foot Right of Way line a distance of 210.0 feet to the point of beginning; thence continue N 78° 39' E along said 40 foot Right of Way line a distance of 106.0 feet to a point 40.0 feet left of P. C. station 13+04.9; thence continue Northeasterly along said 40 foot Right of Way line along a curve to the right (concave Southwesterly) and having a radius of 756.20 feet a distance of 108.0 feet to a point on the East property line of said grantor; thence run South along said East property line a distance of 45.0 feet to a point in the center of the present dirt road; thence run Southwesterly along the center of said dirt road a distance of 212.0 feet to a point on the West property line of said grantor; thence run North along said West property line a distance of 39.0 feet to the point of beginning.

Said parcel of land is lying in the SW $\frac{1}{4}$  of NE $\frac{1}{4}$ , Section 33, T-19S, R-1E and contains 0.20 acres more or less including that part now occupied by the present dirt road.

The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
