Walter Brasher and wife, Eloise Brasher in hand paid by Danny Hilyer the receipt whereof is acknowledged We the said Walter Brasher and wife, Eloise Brasher do grant, bargain, sell and convey unto the said Danny Hilyer

the following described real estate, to wit:

From a point on the northerly right of way line of Alabama Highway No. 25, where the same intersects the west line of the Northwest Fourth of the Southeast Fourth, Section 14, Township 22, Range 2, Shelby County, Alabama, run thence N-72°-48'E along said line of said road for 360.0 feet to an iron pin heretofore set and the point of beginning of the parcel herein described; From said point of beginning, run thence N-0°-57'E for 619.5 feet to a point on the southerly right of way line of the Southern Railroad Company property; run thence S-78°-13'E along said railroad right of way line for 411.2 feet to a point; run thence N-0°-57'W for 409.8 feet to a point on the northerly right of way line of said Highway No. 25; run thence S-72°-48'W, along said line for 425.0 feet, to the point of beginning. 
