## RIGHT-OF-WAY DEED FOR PUBLIC ROAD

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, \_\_\_\_\_

\_\_\_\_\_ and wife \_\_\_\_\_ of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be

\_\_\_\_\_ feet in width on \_\_\_\_\_ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a \_\_\_\_\_ foot right-of-way across our lands, said right-of-way herein conveyed being more particularly described as follows, to-wit: And as shown on the right-of-way map of Project No. \_\_\_\_\_ as recorded in the office of the Judge of Probate of Shelby County.

Commence at the Northeast corner of the NE $\frac{1}{4}$  of SW $\frac{1}{4}$ , Section 34, T-19S, R-1E and run South along the East boundary line of said quarter quarter section a distance of 40.0 feet to a point on the center line of Project CP4-159 at station 74+06; thence run Southwesterly along said center line along a 3° curve to the right (concave Northwesterly) a distance of 29.8 feet to a point on said center line at P. C. station 73+76.2; thence run S 84° 42' W along said center line a distance of 304.0 feet to a point at P. T. station 70+72.2; thence continue Southwesterly along said center line along a 4° curve to the left (concave Southeasterly) a distance of 358.0 feet to the point of beginning on the East property line of said grantor; thence run South along said property line a distance of 44.0 feet to a point on the Southeast 40 foot Right of Way line of said project; thence run Southwesterly along said 40 foot Right of Way line along a curve to the left (concave Southeasterly) and having a radius of 1392.39 feet a distance of 89.0 feet to a point in the center of the present dirt road; thence run Southwesterly along the center of said dirt road a distance of 360.0 feet to a point on the Northwest 40 foot Right of Way line of said project; thence run North-easterly along said Right of Way line along a curve to the right (concave Southeasterly) and having a radius of 1472.39 feet a distance of 492.0 feet to a point on the East property line of said grantor; thence run South along said East property line a distance of 44.0 feet to the point of beginning.

Said parcel of land is lying in the NE $\frac{1}{4}$  of SW $\frac{1}{4}$ , Section 34, T-19S, R-1E and contains 6.51 acres more or less including that part now occupied by the present dirt road.
