

RIGHT-OF-WAY DEED FOR PUBLIC ROAD

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned,

_____ and wife _____ of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be

_____ feet in width on _____ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a _____ foot right-of-way across our lands, said right-of-way herein conveyed being more particularly described as follows, to-wit: And as shown on the right-of-way map of Project No. S-5910 (101) as recorded in the office of the Judge of Probate of Shelby County.

PARCEL I

Commence at the Northeast corner of the NE $\frac{1}{4}$ of SE $\frac{1}{4}$, Section 13, T-20S, R-4W and run South along the East boundary line of said Quarter Quarter Section a distance of 32.0 feet to a point on the Northeast 50 foot Right of Way line of Project S-5910 (101); thence continue South along said East boundary line and crossing the center line of said Project at Station 20+20 a distance of 155.0 feet to a point on flare of access road; thence continue along said East boundary along said flare a distance of 55.0 feet to the point of beginning on the Northwest 30 foot Right of Way line of said access road; thence continue South along said East boundary line and crossing the center line of said access road at Station 1+11.0' a distance of 91.0 feet to a point on the Southeast 30 foot Right of Way line of said access road; thence run Southwesterly along said Right of Way line along a curve to the left (concave Southeasterly) and having a radius of 199.18 feet a distance of 43.0 feet to a point on the Northeast 40 foot Right of Way line of County Highway 52; thence run Northwesterly along said Northeast 40.0 foot Right of Way line along a curve to the left (concave Southwesterly) and crossing the center line of said access road at Station 1+45 a distance of 109.0 feet to a point on the Northwest 30 foot Right of Way line of said access road; thence run Northeasterly along said 30 foot Right of Way line along a curve to the right (concave Southwesterly) and having a radius of 259.18 feet a distance of 31.0 feet to the point of beginning.

Said parcel of land is lying in the NE $\frac{1}{4}$ of SE $\frac{1}{4}$, Section 13, T-20S, R-4W and contains 0.05 acres more or less.

The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
