KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, _____

_____ and wife _____ of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be

_____ see below _____ feet in width on _____ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a _____ foot right-of-way across our lands, said right-of-way herein conveyed being more particularity described as follows, to-wit: And as shown on the right-of-way map of Project No. CP3-165 as recorded in the office of the Judge of Probate of Shelby County.

Begin at the southeast corner of the SE $\frac{1}{4}$ of SE $\frac{1}{4}$, Section 4, T 19 S, R 2 W, (said corner being on centerline of Project CP3-165 at Station 8+55.25) and run north along the east boundary line of said quarter quarter section a distance of 39.0 feet to a point on the northwest 30 foot right of way line of said project; thence run S 57° 22' W along said right of way line a distance of 68.0 feet to a point on the south boundary line of said quarter quarter section; thence run east along said south boundary line a distance of 58.0 feet to the point of beginning.

Said parcel of land is lying in the SE $\frac{1}{4}$ of SE $\frac{1}{4}$, Section 4, T 19 S, R 2 W and contains 0.02 acres, more or less.

The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
