

Excepting, however, the right of way of the Central of Georgia Railroad and the Atlantic Coast line Railroad and the Section house lots and other holdings of the Central of Georgia Railroad and Atlantic Coast Line Railroad running through said lands." and also, all of the following described real estate lying East of Shelby County Highway #____ and South of the A. C. L. Railroad, "Five acres in the NE corner of the SEA of NEA of Section 22, Township 19, Range 2 East, being 110 yards wide East and West and 220 yards long North and South. Thirty acres off the West side of the SE4 of NE4 of Section 23, and No of SWo of NE and No of SE of SE and SWo and SWo of NWo of Section 23, and SEZ of NNZ of Section 24, all in Township 19, Range 2 East, subject to right of way of Central of Georgia Railroad Co. and A.
