The said tract or parcel of land being situated in Shelby County, Alabama, containing 188 acres, more or less, and being more particularly described as follows:

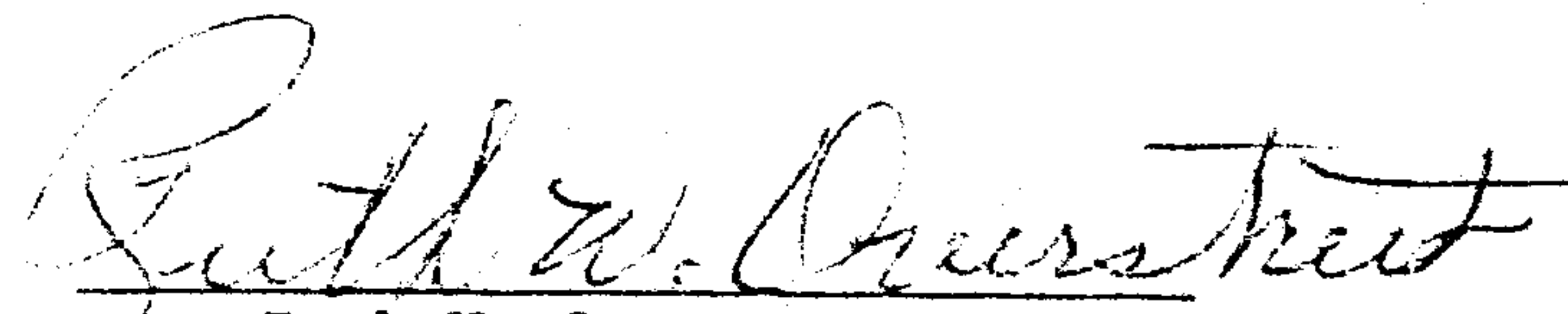

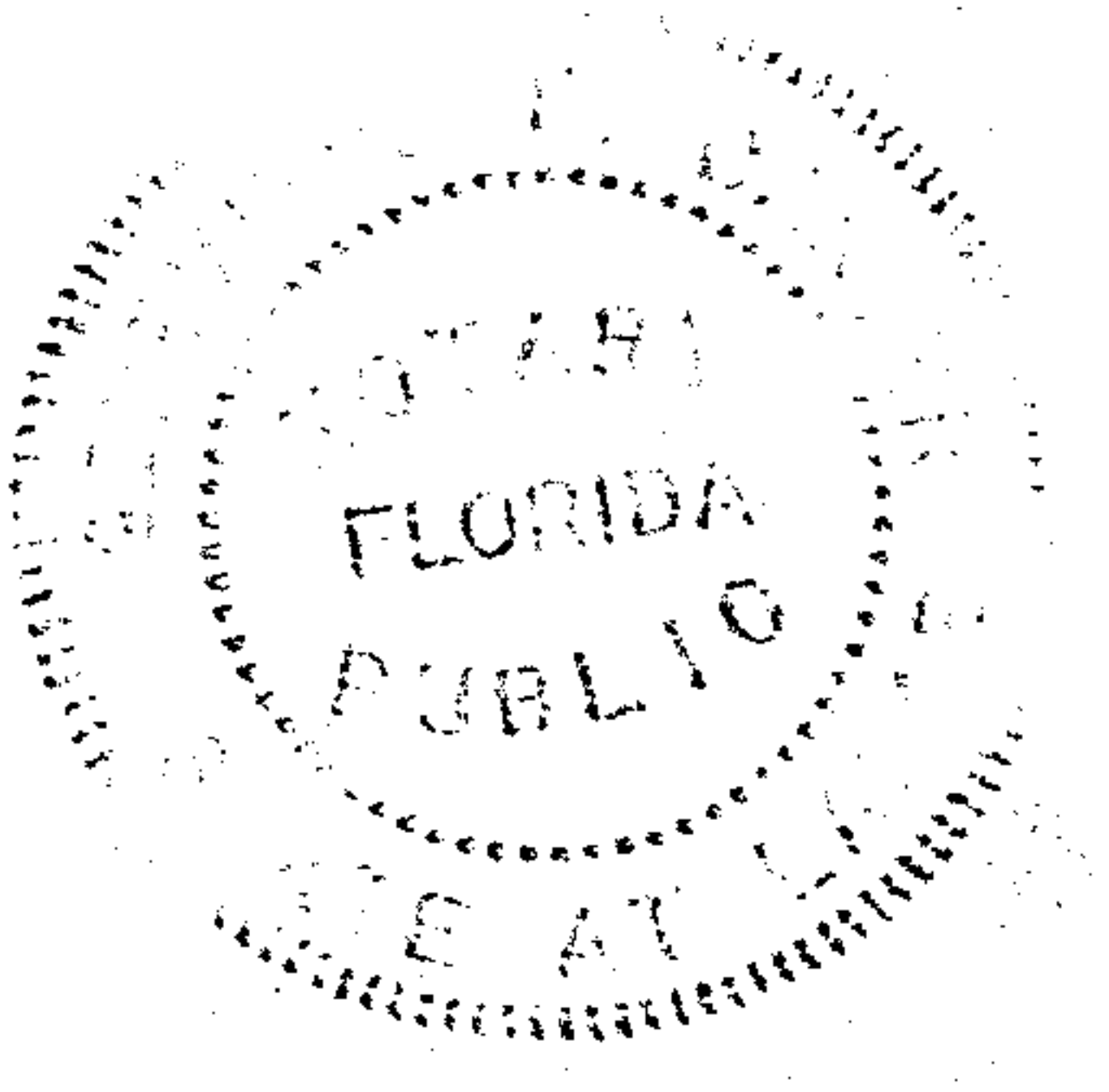
