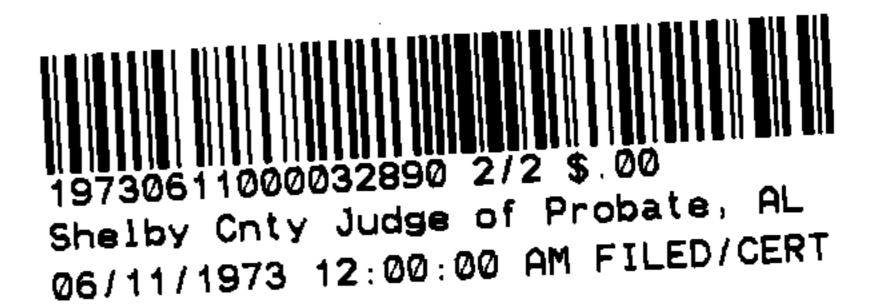

## "EXHIBIT A"

THE FOLLOWING DESCRIBED REAL ESTATE, BUILDING AND IMPROVEMENTS THEREON INCLUDING THE LAND LOCATED IN SHELBY COUNTY, ALABAMA, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Commence at the Southwest corner of the Southeast Quarter of the Southwest Quarter of Section 16, Township 19 South, Range 2 West, Shelby County, Alabama; thence from the South line of said quarter-quarter turn an angle to the left of 45 degrees 46 minutes 52 seconds and run in a Northeasterly direction a distance of 722.26 feet to the point of beginning; thence continue on last described course a distance of 613.68 feet to it's interesection with the Southeasterly right-of-way line of Valleydale Road; thence run in a Southwesterly direction along the arc of a curve along the said South easterly right-of-way line of Valleydale Road along a curve (angle from last described course to tangent of said curve is 163 degrees 42 minutes 26 seconds (having a central angle of 19 degrees 44 minutes 27 seconds and a radius of 1,389.21 feet; thence continue along the arc of said curve a distance of 478.63 feet to the end of said curve; thence continue in a Southwesterly direction along the tangent of last described curve, continuing along said Southeasterly right-of-way line of Valleydale Road, a distance of 140.64 feet; thence turn an angle to the left of 86 degrees 33 minutes 07 seconds and run in a Southeasterly direction a distance of 44.82 feet to the point of beginning.
