

QUITCLAIM DEED (Jointly for Life with Remainder to Survivor)

KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of the sum of Two Hundred and No/100 (\$200.00)----- in hand paid to the undersigned, the receipt whereof is hereby acknowledged, the undersigned W. J. Lewis, Jr., and wife, Bessie H. Lewis, hereby remises, releases, quit claims, grants, sells and conveys to Chester A. Cox and wife, Bessie B. Cox (hereinafter called Grantees) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:

Part of the SW 1/4 of the SE 1/4 of Section 15, Township 21 South, Range 3 West, Shelby County, Alabama, more particularly described as follows:

Begin at the SE corner of the SW 1/4 of the SE 1/4 of Section 15, Township 21 South, Range 3 West, Shelby County, Alabama; run thence West along Section line 663.22 feet; thence, turning an angle of 88 degrees and 24 minutes and run North 318.71 feet to the point of beginning of property herein described; thence, run East 331.44 feet to the center of a road; thence, North along center of said road 343.95 feet to the center of a road running East and West; thence, West along center of said road 331.30 feet; thence, South 343.71 feet to the point of beginning. Except the North 25 feet and the East 25 feet of the above described property for roadway.

This QuitClaim Deed is given for the purpose of correcting the legal description contained in the deed from Grantors to Grantees herein recorded in Deed Book 251, Page 698.
