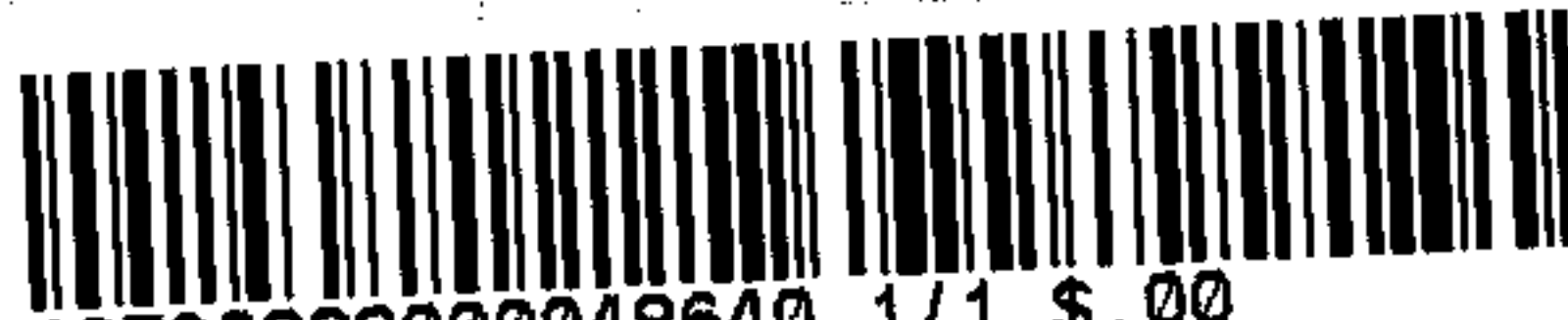

We the right to install and maintain anchors and guy wires on said land
Said lines are now constructed or may hereafter be constructed along the margin of the public road leading

and known as Road.

~~In the event it becomes necessary or desirable for Alabama Power Company to move its lines or poles, towers and appliances in connection with the construction or improvement of any public road or highway in proximity to its said power lines, the said Company is hereby granted the right to relocate its said lines or poles, towers and appliances on lands of grantors hereinbefore described, provided, however, the said Company shall relocate its said line of poles or towers at a distance not greater than ten feet outside the boundary of the right of way of any such public road or highway as established or reestablished from time to time.~~

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns forever.
