the receipt of which is hereby acknowledged, the said BURNETT BUILDING SERVICE, INC.  
does by these presents, grant, bargain, sell and convey unto the said ROY MARTIN CONSTRUCTION, INC.

the following described real estate, situated in SHELBY COUNTY, ALABAMA, to-wit:
