TIMBER DEED



KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of One Thousand and no/100 Dollars (\$1,000.00) to the undersigned grantors James Crawford Dorough and wife, Sylvia W. Dorough, in hand paid by Lewis B. Walker, the receipt whereof is hereby acknowledged, we, the said James Crawford Dorough and wife, Sylvia W. Dorough, do hereby grant, bargain, sell and convey unto the said Lewis B. Walker all merchantable pine timber located on the following described land:

Approximately 1/4 acres located in the Northwest Corner of SE $\frac{1}{4}$  of NW $\frac{1}{4}$ , Section 7, Township 20, Range 1 East, situated in Shelby County, Alabama,

together with full and free right of ingress and egress to and from said land at any and all times until Six Months from the date of this deed, for the purpose of cutting and removing said timber, but after said time grantee shall have no further giths or interest in said land or timber uncut and at the expiration of said time, said land and all uncut timber shall revert to the grantors herein.

And we do for ourselves and for our heirs, executors, and administrators covenant with the said Lewis B. Walker, his heirs and assigns, that we are lawfully seized of said premises in fee simple; that it is free from all encumbrances and we have a good right to sell and convey said timber as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to the said Lewis B. Walker, his heirs and assigns against the lawful claims of all persons.


