(herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto

Diane B. Ellis

(herein referred to as grantee, whether one or more), the following described real estate, situated in

SHELBY

County, Alabama, to-wit:

A part of the SE $\frac{1}{4}$  of the NE $\frac{1}{4}$  of Section 36, Township 21, Range 1 West, more particularly described as follows: Begin at the NW corner of the SE $\frac{1}{4}$  of the NE $\frac{1}{4}$  of said Section and run thence in an easterly direction along the northern boundary of said SE $\frac{1}{4}$  of NE $\frac{1}{4}$  a distance of 315 feet more or less to an iron stake, which said iron stake is located several feet east of a branch and located on the northern boundary of said  $\frac{1}{2}$   $\frac{1}{2}$  Section; thence turn to the right and run in a southeasterly direction to a point on the northern boundary of paved Mooney Road, which said point is marked by an iron stake and is located 36 feet more or less in an easterly direction along the edge of said paved road from a point where the said edge of said road is intersected by the branch or creek referred to above; thence turn to the right and run in a westerly direction along the edge of said paved road to a point where the same intersects the western boundary of said SE $\frac{1}{4}$  of NE $\frac{1}{4}$ ; thence turn to the right and run in a northerly direction along the western boundary of said SE $\frac{1}{4}$  of NE $\frac{1}{4}$  to the point of beginning, containing three-fourth acres, more or less.
