KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned James E. Pardue, Sr. and wife, Jewel Pardue, of the county of Shelby and State of Alabama, in and for the consideration of One Dollar, in hand paid by Charles Seales, the receipt whereof is hereby acknowledged, do hereby give, grant, bargain, sell and convey unto Charles Seales, his heirs or assigns, a right-of-way hereinafter described, over and across my lands in Shelby County, Alabama, for a road right-of-way, said right-of-way herein conveyed being more particularly described as follows, to-wit:

Commence at the northwest corner of the NW $\frac{1}{4}$  of the NE $\frac{1}{4}$  of Section 3, Township 24 North, Range 13 East, which said corner is marked by an angle iron driven in the ground, and run thence south 88 deg. 09 min. west along Freeman's Base Line, a distance of 176.70 feet to an iron pin driven in the ground on Freeman's Base Line; thence run south 25 deg. 20 min. East a distance of 1006.64 feet to an iron pipe driven in the ground; run thence South 68 deg. and 20 min. West a distance of 210.0 feet to the point of beginning; thence continue south 25 deg. 20 min. West a distance of 33.0 feet; thence turn an angle of 136 deg. 04 min. 23 sec. to the right and run a distance of 43.16 feet; thence turn an angle of 130 deg. 15 min. 37 sec. to the right and run a distance of 30.0 feet to the point of beginning; situated in the NW $\frac{1}{4}$  of the NE $\frac{1}{4}$  of Section 3, Township 24 North, Range 13 East, Shelby County, Alabama.

TO HAVE AND TO HOLD to the said Charles Seales, his heirs or assigns forever.
