For a point of beginning run South 17 deg. east 1.81 chains from the east end of a concrete culvert, under the state highways located in January, 1930, to a point on the east boundary of said highway 10 feet north of the NW corner of the Carl Smith's two acre lot; thence north 89 deg. east 6.36 chains to iron state 10 feet north of the NE corner of the Carl Smith lot; thence North 18 deg. west 6.36 chains to rock corner, thence North 88 deg. west 6.36 chains to right of way of State Highway, thence south 17 deg. East 6.36 chains to beginning point, and containing 4 acres, more or less, in the SW 1/4 of SW 1/4 of Section 24, Township 20, Range 3 West. EXCEPT New Highway right of way.
