to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,

(herein referred to as grantors) do grant, bargain, sell and convey unto
William Anderson and wife, Mary Anderson

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

From the Northeast corner of the SE¼ of the SW¼ of Section 36, Township 20 South, Range 3 West run Southerly along the East boundary line of said quarter-quarter section 90.0 feet to the point of beginning of the land herein described; thence continue Southerly along the East boundary line of said quarter-quarter section for 90.0 feet; thence turn right an angle of 91 deg. 21 min. and run Westerly 257.64 feet; thence turn right an angle of 90 deg. and run Northerly 90.0 feet; thence turn right an angle of 90 deg. and run Easterly 254.65 feet, more or less, to the point of beginning.
