FOR AND IN CONSIDERATION OF ONE AND NO/100 (\$1.00) DOLLARS, to ANNIE BREWSTER and husband, EARL SELF, (hereinafter called landowners) in hand paid by WILLIAM BREWSTER (hereinafter called timberman), the receipt of which is hereby acknowledged, landowners do hereby grant, bargain, sell, and convey to timberman, an undivided 1/2 interest in and hardwood saw timber and pulpwood, now standing and growing on the hereinafter described lands situated in Shelby County, Alabama:

The NE¹/₄ of NW¹/₄; the NW¹/₄ of NE¹/₄, less highway right of way; the SE¹/₄ of NE¹/₄ less 34¹/₂ acres on East side sold to Atchison, being 5¹/₂ acres, more or less; and the SW¹/₄ of NE¹/₄ as conveyed to W. B. Brewster by Alabama Lime and Stone Corporation by deed dated June 25, 1929, less any portion that may have been conveyed heretofore; all in Section 5, Township 22 South, Range 2 West.

TO HAVE AND TO HOLD to said timberman, his heirs and assigns, for 9 months, with right of ingress, egress, and regress, to, from and over said land for the purpose of cutting and removing said timber; but it is agreed that all timber left on said land at the expiration of said time shall revert to and become the property of the said landowners, their heirs and assigns.

And said landowners do hereby covenant with said timberman, that they are the owners of said land, that it is free from encumbrance, that they have a good right to sell the timber thereon, and that he will not be molested or interfered with while cutting and removing said timber.
