(herein referred to as grantee, whether one or more), the following described real estate, situated in

Shelby County, Alabama, to-wit:

From the Southeast corner of the NW $\frac{1}{4}$ of Section 32, Township 21 South, Range West, the point of beginning of the herein described tract; run Northerly along the line of Horton property on the East 1,295.84 feet to a 5/8 inch iron pin on the East line of said quarter; thence Westerly along the line of Law Kite property on the North deflecting 91 deg. 52 min. 34 sec. left 1,297.51 feet to a 5/8 inch iron pin on the East right of way line of County Road Number 97; thence Southeasterly along said East right of way line of County Road Number 97 deflecting 91 deg. 3 min. 0 sec. left 177.06 feet to a 5/8 inch iron pin, the point of curve; thence continuing Southeasterly along an arc of a curve to the left having a central angle of 44 deg. 45 min. 30 sec., radius of 326.78 feet for a curve distance of 255.27 feet to a 5/8 inch iron pin, the point of tangent; thence continuing Southeasterly along said East right of way line of County Road Number 97 299.45 feet to a 5/8 inch iron pin, the point of curve; thence Southeasterly along an arc of a curve to the left having a central angle of 33 deg. 3 min. 20 sec., radius of 240.7 feet for a curve distance of 138.87 feet to a point, the point of reverse curve; thence continuing Southeasterly from the point of reverse curve along an arc of a curve to the right having a central angle of 34 deg. 0 min. 32 sec., radius of 214.30 feet for a curve distance of 127.20 feet to a 5/8 inch iron pin, the point of tangent; thence continuing Southeasterly 787.56 feet to a 5/8 inch pin, on said East right of way line of County Road Number 97, and on the South line of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 32, Township 21 South, Range 1 West; thence Easterly along the South line of said quarter, quarter deflecting 45 deg. 12 min. 30 sec. left 150.63 feet to a 2 1/2 inch capped pipe, the point of beginning; containing 25.0 acres by survey, according to survey of Reese E. Mallette, Jr., Registered Land Surveyor, dated September 1973.
