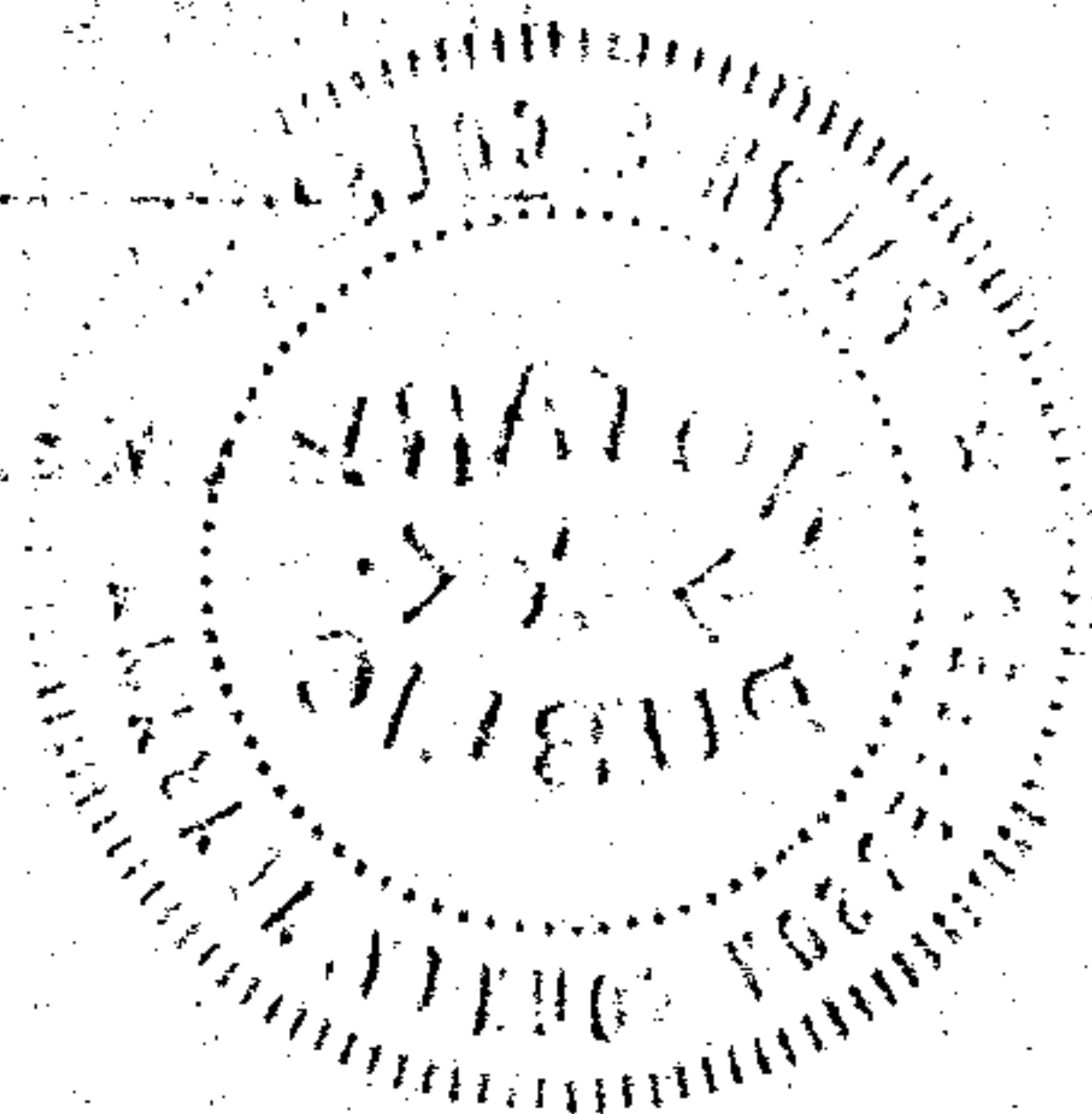
KNOW ALL MEN BY THESE PRESENTS, for and in consideration of the

 Alabama, the receipt of which is hereby acknowledged, we (I), the undersigned, grant-
 or(s), Louis G. Mason Jr. & Wife Louise Orutt Mason, have (has)
 this day bargained and sold, and by these presents do hereby grant, bargain, sell and
 convey unto the State of Alabama the following described property, lying and being
 in Shelby County, Alabama, and more particularly described as
 follows: and as shown on the right-of-way map of Project No.
 F-214(20) as recorded in the Office of the Judge of Probate
 of Shelby County, Alabama:

Commencing at the southeast corner of the NE $\frac{1}{4}$ of SE $\frac{1}{4}$,
 Section 26, T-19-S, R-1-W; thence northerly along the east
 line of said NE $\frac{1}{4}$ of SE $\frac{1}{4}$, a distance of 1375 feet, more or
 less, to a point that is 150 feet southwesterly of and at
 right angles to the centerline of Project No. F-214(20) and
 the point of beginning of the property herein to be conveyed;
 thence N 87° 24' 08" W, parallel to the centerline of said
 project, a distance of 332 feet, more or less, to the north
