of Shelby County, Alabama:

Commencing at the southwest corner of the NW $\frac{1}{4}$ of SW $\frac{1}{4}$,
Section 28, T-19-S, R-1-E; thence northerly along the west
line of said NW $\frac{1}{4}$ of SW $\frac{1}{4}$, a distance of 1035 feet, more or less,
to a point that is 150 feet southeasterly of and at right angles
to the centerline of Project No. F-214(20); thence N 84° 44' 57"
E, parallel to the centerline of said project, a distance of
640 feet, more or less, to the west line of the property herein
