do grant, bargain, sell and convey unto the said
Otis W. McCall and Ocie L. McCall
our undivided one-third interest in and to
the following described real estate situated in Shelby County, Alabama, to-wit:
Commence at the southeast corner of SE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 34, Township 19, Range 2
East and run south, 87 degrees 30 minutes west, 229.83 feet to the easterly right
of way line of U. S. Highway No. 280 (also known as Ala. Highway 91) and run north
56 degrees 20 minutes west, along said right of way line 1750 feet to an iron pin,
to the point of beginning of the land herein conveyed, which point of beginning is
the westmost corner of a lot known as the Abbott lot; thence north, 33 degrees
40 minutes east, 266.44 feet to an iron pin; thence north, 56 degrees 20 minutes
west, 120 feet; thence south, 33 degrees 40 minutes west, 266.40 feet to the
