the undersigned hereby releases, quitclaims, grants, sells, and conveys to John Walker and Pearlene Walker, for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, (hereinafter called Grantee), all my right, title, interest, and claim in or

to the following described real estate, situated in Shelby

County, Alabama, to-wit:

Commence at the northeast corner of the SE 1/4 of NE 1/4, Section 35, Township 21 South, Range 1 West and run in a southerly direction along the east boundary line of said quarter section a distance of 15.0 feet to the point of beginning in the center of old dirt road; thence run in a westerly direction along the center of said dirt road a distance of 362 feet to the point of ending on the west property line of the B.
