Tract #1: Part of the N 1/2 of SE 1/4, Section 15, Township 20 South, Range 3 West, Shelby County, Alabama, said part being more particularly described as follows: Beginning at a point on the south line of said N 1/2 of SE 1/4, which is 1746.96 feet west of the southeast corner of said N 1/2 of SE 1/4, run thence west along said south line for a distance of 442.44 feet, thence turn an angle to the right of 78 deg. 20' and run northwesterly for a distance of 263.59 feet, thence turn an angle to the right of 100 deg. 42' and run easterly for a distance of 496.12 feet, thence turn an angle to the right of 91 deg. 02" and run southerly for a distance of 266.54 feet to the point of beginning, containing 2.83 acres, more or less.

Tract #2: Part of the N 1/2 of SE 1/4, Section 15, Township 20 South, Range 3 West, Shelby County, Alabama, said part being more particularly described as follows: Beginning at the intersection of the south line of said N 1/2 of SE 1/4 with the centerline of Prairie Branch, which is about 1300 feet west of the southeast corner of said N 1/2 of SE 1/4, run thence west along said south line for about 447 feet to a point which is 1,746.96 feet west of the southeast corner of said N 1/2 of SE 1/4, thence turn an angle to the right of 90 deg. 04' and run northerly for a distance of 266.54 feet, thence turn an angle to the right of 88 deg. 58' and run easterly for a distance of 210 feet, more or less, to the centerline of Prairie Branch, run thence southeasterly along the center of Prairie Branch for a distance of 350 feet, more or less, to the point of beginning, containing 1.9 acres, more or less.
