Begin at the northermost corner of lot 40, original plan of Town of Montevallo, situated in Shelby County, Alabama, thence in a southerly direction along the boundry line between lots 40 and 39, a distance of 109 feet to the point of beginning; thence in a southerly direction along waid boundry of lot 40 a distance of 41 feet, thence perpendicular to said boundry of lot 40, in a westerly direction a distance of 37½ feet, thence in a northerly direction, parallel to said boundry of lot 40 a distance of 41 feet, thence in an easterly direction, perpendicular to said boundry of lot 40 a distance of 37½ feet to the point of beginning, this being a rectangular lot 41 feet by 37½ feet, with its easternmost boundry being 41 feet on the boundry of lot 40 and 39 of original plan of Montevallo, situated in Shelby County, Alabama.
