That in consideration of One hundred and no/100 dollars and other good and valuable consideration

to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we, Ralph W. Hill and Janice C. Hill, his wife

(herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto

John G. Halbert

(herein referred to as grantees, whether one or more), the following described real estate, situated in

Shelby County, Alabama, to-wit:

A parcel of land located in the NW 1/4 of the SE 1/4 of Section 35, Township 21 South, Range 3 West, Shelby County, Alabama, described as follows: Commence at the NE corner of the SW 1/4 of the NE 1/4 and run South along the East boundary of said 1/4-1/4 section and South along the East boundary of the NW 1/4 of the SE 1/4 a distance of 1,720.6 feet to the point of beginning; From the point of beginning continue last course 891.0 feet, thence turn right 93 deg. 58' and run Westerly 1,258.3 feet to a point of the Easterly right of way Alabama Highway #119; thence turn right and run Northerly along the right of way of said highway along the arc of a 0 deg. 30' curve to the right, said arc being subtended by a chord 883.6 feet, thence from said chord turn right 85 deg. 27' and run 1,132.0 feet to the point of beginning.

LESS AND EXCEPT:

A parcel of land located in the Northwest 1/4 of the Southeast 1/4 of Section 35, Township 21 South, Range 3 West, Shelby County, Alabama, more particularly described as follows: Commence at the northeast corner of the Southwest 1/4 of the Northeast 1/4 of Sec. 35, Township 21 South, Range 3 West; thence in a Southerly direction along the East line of said 1/4-1/4 section a distance of 1720.6 feet, according to survey of Roy Moore to the point of beginning; thence continue along last described course a distance of 445.0 feet; thence 93 deg. 50' right in a Westerly direction a distance of 1203.86 feet to the Easterly right of way line of Alabama Highway #119; thence 94 deg. 20' 48 seconds right measured to tangent of a curve to the right, said curve having a central angle of 2 deg. 13 minutes 07 seconds and a radius of 11,429.83, thence along arc of said curve in a Northerly direction along said right of way line a distance of 442.58 feet, thence 83 degrees 14 minutes 05 seconds right measured from tangent of said curve, in an easterly direction a distance of 1132.0 feet to the point of beginning.
