Fifty-Five Thousand Nine Hundred and no/100 ————— Dollars  
to the undersigned grantor, Denman Construction Company, Inc.

the receipt whereof is acknowledged, the said Denman Construction Company, Inc.

does by these presents, grant, bargain, sell, and convey unto the said  
L. Stephen Wright Jr. and wife, Marye Jo Wright

as joint tenants, with right of survivorship, the following described real estate, situated in

Shelby County, Alabama, to-wit:

Part of the SW 1/4 of the SE 1/4 of Section 16, Township 19 South, of Range 2 West, and  
also a part of the SE 1/4 of the SE 1/4 of Section 16, Township 18 South of Range 2 West,  
and being more particularly described as follows: Commence at the NE corner of the SW 1/4  
of the SE 1/4 of said Section 16, thence westerly, and along the North line of same for  
a distance of 220.00 feet; thence turn an angle of 49 deg. 38' to the left in a south-  
westerly direction for a distance of 25.02 feet; thence turn an angle of 80 deg. 46' to  
the left in a southeasterly direction for a distance of 150.00 feet; thence turn an angle  
of 80 deg. 46' to the right in a southwesterly direction for a distance of 247.63 feet;  
thence turn an angle of 92 deg. 24' to the left in a southeasterly direction for a distance  
of 186.40 feet; thence turn an angle of 17 deg. 40' to the right for a distance of 64.00  
feet; thence turn an angle of 105 deg. 35' to the left in a northeasterly direction for a  
distance of 202.18 feet; thence turn an angle of 105 deg. 34' to the right in a southeasterly  
direction for a distance of 115.30 feet to the point of beginning of the property described  
herein; thence continue along the last named course for a distance of 117.57 feet; thence turn  
an angle of 79 deg. 41' to the right in a southwesterly direction for a distance of 188.24  
feet; thence turn an angle of 101 deg. 00' to the right in a northwesterly direction for a  
distance of 108.82 feet; thence turn an angle of 76 deg. 07' to the right in a northeasterly


