Dunston in the amount of \$80,000.00. It being understood that Grantee herein shall have an obligation to pay 25 % of the annual installments due on said mortgage and should he fail to make such payment, then his interest in subject property shall be encumbered to the extent of such failure in favor of the party who does make such payment.

It is also understood that the title to subject property is subject to a certain Buy-Sell Agreement entered into by and between the parties who own all of the interest in and to said land.


