King, the following described real estate situated in Shelby County, Alabama,
to-wit:

A parcel of land located in the SE-1/4 of the NW-1/4 and the NE-1/4 of the SW-1/4 of Section 26, Township 20 South, Range 3 West, Shelby County, Alabama, more particularly described as follows: Begin at the Southwest corner of the NE-1/4 of the SW-1/4 of said Section, thence in an Easterly direction along the South line of said 1/4-1/4 section a distance of 891.0 feet; thence 91° 26' left in a Northerly direction a distance of 286.65 feet to the center line of an Alabama Power Company transmission line right of way; thence 23° 26' left in a Northwesterly direction along the center line of said right of way a distance of 1579.74 feet; thence 108° 55' 06" left in a Southwesterly direction a distance of 354.49 feet; thence 47° 38' 54" left in a Southerly direction a distance of 1475.0 feet to the point of beginning, containing 24.08 acres, more or less.
