KNOW ALL MEN BY THESE PRESENTS THAT:

That in consideration of TWENTY THOUSAND FIVE HUNDRED AND NO/100 DOLLARS and other good and valuable consideration as set out hereinbelow, to the undersigned grantor(s), Pan-American Investment, Inc. in hand paid by Gary L. Thompson the receipt whereof is acknowledged hereby, the said Pan-American Investment, Inc. does, grant, bargain, sell and convey unto the said Gary L. Thompson the following described real estate, situated in Shelby County, Alabama, and described as set forth in Exhibit "A" which is attached hereto and made a part hereof.

Subject to any and all easements, restrictions and rights-of-way of record. In addition to the above-recited money consideration, the Grantee herein hereby assumes two existing mortgages encumbering subject property, to-wit: 1. That certain mortgage from R. Lee Walthall and Barbara Noojin Walthall in the amount of \$75,328.00. As further consideration, the Grantee herein hereby assumes three existing but heretofore unrecorded mortgages from R. Lee Walthall and Barbara Noojin Walthall to the following grantees/mortgages: 1. Byron D. Howells and Jean Howells; 2. Reby H. Allen and Norman A. Allen; 3. Rececca D. Howells, each of said unrecorded mortgages having been executed on the 11th day of January, 1974, the unpaid balance on said mortgages totalling \$1,872.00. As further consideration, a Purchase Money Mortgage from Grantee herein to the Undersigned Grantors herein in the amount of \$42,020.00 is being executed simultaneously herewith.


