KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned W. M. Cook and wife, Marsha Cook; Norman L. Collum, a single man; and Robert F. Stagner and wife, Mary Lou Stagner, in and for the consideration of One Dollar in hand paid by Shelby County, the receipt whereof is hereby acknowledged, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a right-of-way hereinafter described, over and across our lands in Shelby County, Alabama, for a public street, said right-of-way herein conveyed being more particularly described as follows, to-wit:

A 30 foot right-of-way on each side of the following described line: Begin at the southwest corner of Section 22, Township 21, Range 3 West; thence in a northerly direction along the west boundary of said Section 450 feet; thence turn 91 deg. 45 min. to the right and run 351.63 feet to the point of beginning of the center line of said right-of-way, this point being located in the middle of an existing road leading from said point of beginning thence turn an angle of 88 deg. 19 min. to the left and run north along the center line of the existing road a distance of 734.0 feet more or less, to the point of intersection of said line with Shelby County Highway No. 30; situated in Shelby County, Alabama.

TO HAVE AND TO HOLD to the said Shelby County, its successors and assigns forever.
