BE IT KNOWN TO ALL WHOM IT MAY CONCERN:

THAT, WHEREAS, by order or decree of the Circuit Court of Shelby County, Alabama, made on November 1, 1973, in the cause of CORILLA CROSS, WALLACE CROSS, a minor 20 years of age, who brings this suit by and in the name of his mother and next friend, CORILLA CROSS, against GRACE KENDRICK, HELEN MALMEADE, SARA SMITHERMAN, and WAYNE HOLT, the Register of said Court was ordered to execute a deed conveying to the hereinafter named grantee herein, all of the right, title, and interest of each of the parties to this cause to the property herein conveyed, all for the purpose of dividing property in kind owned jointly or as tenants in common by the party owners, as established and decreed by this Court in said order of November 1, 1973.

From the Southeast corner of the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$, of Section 14, Township 19 South, Range 2 West, run northerly along the east line of said $\frac{1}{4}, \frac{1}{4}, \frac{1}{4}$ Section 530.70 feet to the point of beginning of land herein described: Thence continue northerly on same course 265.35 feet; thence turn left an angle of 88 degrees, 21 minutes, 30 seconds, and run westerly 660.47 feet to the west line of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said Section; thence turn left an angle of 91 degrees, 34 minutes, 30 seconds, and run southerly 265.00 feet; thence turn left an angle of 88 degrees, 23 minutes, 30 seconds, and run easterly 660.78 feet to the point of beginning, containing 4.0 acres more or less, and being a part of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$, and the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 14, Township 19 South, Range 2 West.
