KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of ONE HUNDRED THOUSAND DOLLARS (\$100,000.00) in hand paid by PEGGY SPAIN McDONALD (hereinafter referred to as "GRANTEE"), to the undersigned THE HARBERT-EQUITABLE JOINT VENTURE, under Joint Venture Agreement dated January 30, 1974, composed of Harbert Construction Corporation, a corporation, and The Equitable Life Assurance Society of the United States, a corporation (hereinafter referred to as "GRANTOR"), the receipt of which is hereby acknowledged, the said GRANTOR does by these presents grant, bargain, sell and convey unto the said GRANTEE the following described real estate situated in Shelby County, Alabama:

A tract of land containing 4.74 acres, more or less, and located in the west one-half of the northwest quarter (W1/2 of NW 1/4) of Section 29, Township 19 South, Range 2 West, Shelby County, Alabama, being more particularly described as follows:

Start at the southeast corner of the southwest quarter of the northwest quarter of Section 29, Township 19 South, Range 2 West of the Huntsville Meridian; thence north $89^{\circ} 14' 05''$ west along the south boundary of said northwest quarter a distance of 526.01 feet to an iron pipe; thence north $00^{\circ} 23' 05''$ west a distance of 1166.55 feet to an iron rod for a point of beginning.
