(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

A part of the NW¼ of SW¼ of Section 13, Township 22 South, Range 4 West, Shelby County, Alabama, being also a part of property recorded in Deed Book 302, page 89, more particularly described as follows:

Beginning at the SE corner of said ¼ ¼ Section; thence run North along the East line of said ¼ ¼ Section 978.00 feet to a point 331.20 feet south of the NE corner of said ¼ ¼ Section; thence turn 91 deg. 51 min. to the left and run West 498.03 feet to a point, said point being the true point of beginning; thence turn 90 deg. 00 min. left and run South 301.00 feet to a point; thence turn 90 deg. 00 min. right and run West 312.33 feet to a point on the NE right-of-way line of Shelby County Road No. 10; thence turn right and run northwesterly along said right-of-way on a curve to the right, of radius of 675.74 feet, for an arc length of 339.24 feet to a point of tangent; thence run northwesterly along R.O.W. 21.70 feet; thence turn 109 deg. 22 min. right and run East 510.00 feet to the point of beginning.
