Alabama, except a portion thereof conveyed to Carol C. Bolin and wife, Mary
A. Bolin, on September 19, 1967, as described below, and

WHEREAS, there is a well located at or near the dwelling situated on the
portion of said Lot 11 of said Valley Dale Estates designated above as be-
longing to the undersigned Carol C. Bolin and wife, Mary A. Bolin,
but deceased during their joint lives and upon the death of either of them, then
that there is no well located on the said portion of said Lot No. 11 of said
Valley Dale Estates, less in fee simple, and to the heirs and assigns of such
Bolin, described as follows, viz.:

Begin at the NE corner of Lot 11, Valley Dale Estates,
as recorded in Map Book 4, page 90, in the Office of
the Judge of Probate, Shelby County, Alabama; thence run
south along the east line of Lot 11, a distance of 293.18
feet; thence turn an angle of 132 deg. 50.0 min. to the
right and run a distance of 199.33 feet to the east line
of Valley Dale Road; thence turn an angle of 90 deg. 00
min. to the right and run along said Valley Dale Road a
distance of 215.00 feet to the point of beginning, being
a part of Lot 11, Valley Dale Estates.

convey unto said Carol C. Bolin and wife, Mary A. Bolin, for and during their
joint lives and upon the death of either of them, then to the survivor of
them in fee simple, and to the heirs and assigns of such survivor forever,
together with every contingent remainder and right of reversion, the follow-
ing described property situated in Shelby County, Alabama, to-wit:

The easement, right, liberty, privilege or advantage to
enter upon:

That portion of Lot 11, Valley Dale Estates,
recorded in Map Book 4, page 90, in the Office
of the Judge of Probate of Shelby County, Ala-
bama, less and except that portion of said Lot
No. 11 heretofore conveyed to the Grantees,
Carol C. Bolin and wife, Mary A. Bolin, on
September 19, 1967, as described specifically
above,

for the purpose of connecting to the well located on
said lands of grantors as hereinabove described, and
to the water pump situated therein, and to withdraw

from said well through the said pump and convey through pipes which are now installed (or which may hereafter be installed) water from said well located on said lands of the undersigned grantors, in sufficient quantity to supply the domestic needs for one family as occupants of a certain residence located on the lands of grantees herein, as hereinabove described, hereby granting and conveying to grantees herein, their heirs and assigns, the free and unrestricted right to obtain from said well by means of grantors' pump located therein so much water as may be necessary to supply the domestic needs of said premises of the grantees herein, their heirs or assigns.

Together with all and singular the tenements and appurtenances thereto belonging or in any wise appertaining.

TO HAVE AND TO HOLD to the said Carol C. Bolin and wife, Mary A. Bolin, for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.
