Cates, in hand paid by Lewis B. Walker, the receipt whereof is hereby acknowledged, we the said John Lewis Cates and wife, Jacquelyn H. Cates do hereby grant, bargain, sell and convey unto the said Lewis B. Walker, all merchantable timber located on the following described land:

The SW $\frac{1}{4}$ of NW $\frac{1}{4}$ and NW $\frac{1}{4}$ of SW $\frac{1}{4}$, Section 18, Township 21 South, Range 1 East, lying Northwest of Southern Railroad and South of Stinson Spring Branch;

The S $\frac{1}{2}$ of SE $\frac{1}{4}$ of NE $\frac{1}{4}$, and NE $\frac{1}{4}$ of SE $\frac{1}{4}$, and SE $\frac{1}{4}$ of SE $\frac{1}{4}$, SW $\frac{1}{4}$ of SE $\frac{1}{4}$, Section 13, Township 21 South, Range 1 West, lying Northwest of Southern Railroad.

Situated in Shelby County, Alabama.,

together with full and free right of ingress and egress to and from said land for a period of TWELVE MONTHS for the purpose of cutting and removing said timber, but after said time, grantee shall have no further rights or interest in said land or timber uncut and at the expiration of said time, said land and all uncut timber shall revert to the grantors herein.
