Nix, Edgar Roy Nix, Nellie Lucille Nix Dixon, and Lydia Nix Anderson (herein referred to as grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

The North East Quarter of the Southwest Quarter (NE 1/4 of SW 1/4) and thirty acres off the west half of the Southeast Quarter (W 1/2 of SE 1/4) of Section 16, township 22, range 3 West North of Montevallo and Ashville road; and 40 acres in the South half of the Northeast Quarter (S 1/2 of Ne 1/4) of Section 16, township 22, range 3 West and more particularly described as follows: Commence at the South East corner or I.
