(herein referred to as Grantees) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:

A part of the NW $\frac{1}{4}$ of Section 4, Township 22 South, Range 3 West, lying Northeast of Woods Creek, more particularly described as follows: Commence at a point where the western boundary of the Montevallo Elyton Road crosses Woods Creek and run thence in a Northwesterly direction a distance of 778 feet, more or less, along the western boundary of the Montevallo Elyton Road to point of beginning, which said point of beginning is the Northeastern corner of lot being this date conveyed to Milton G. 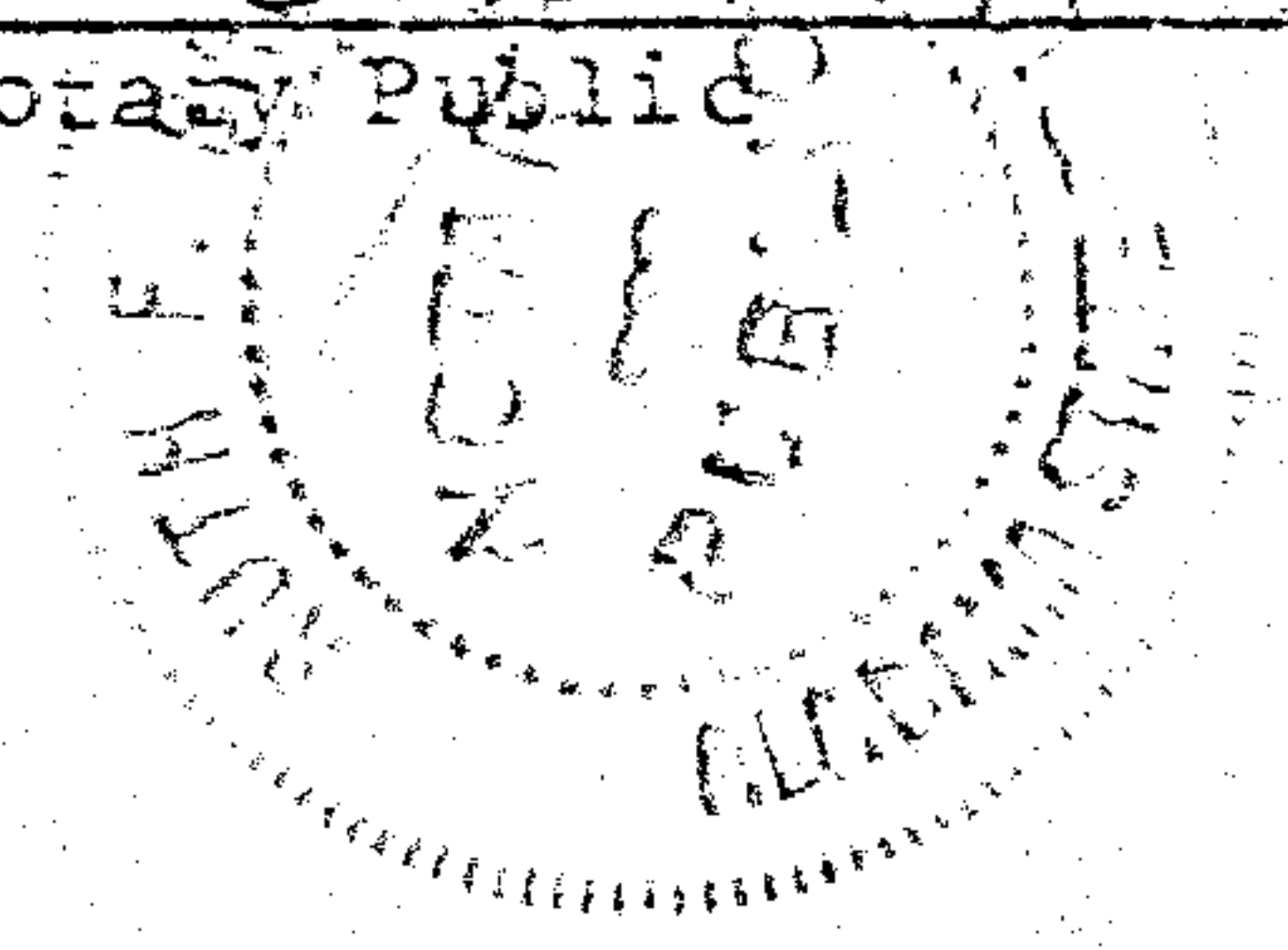

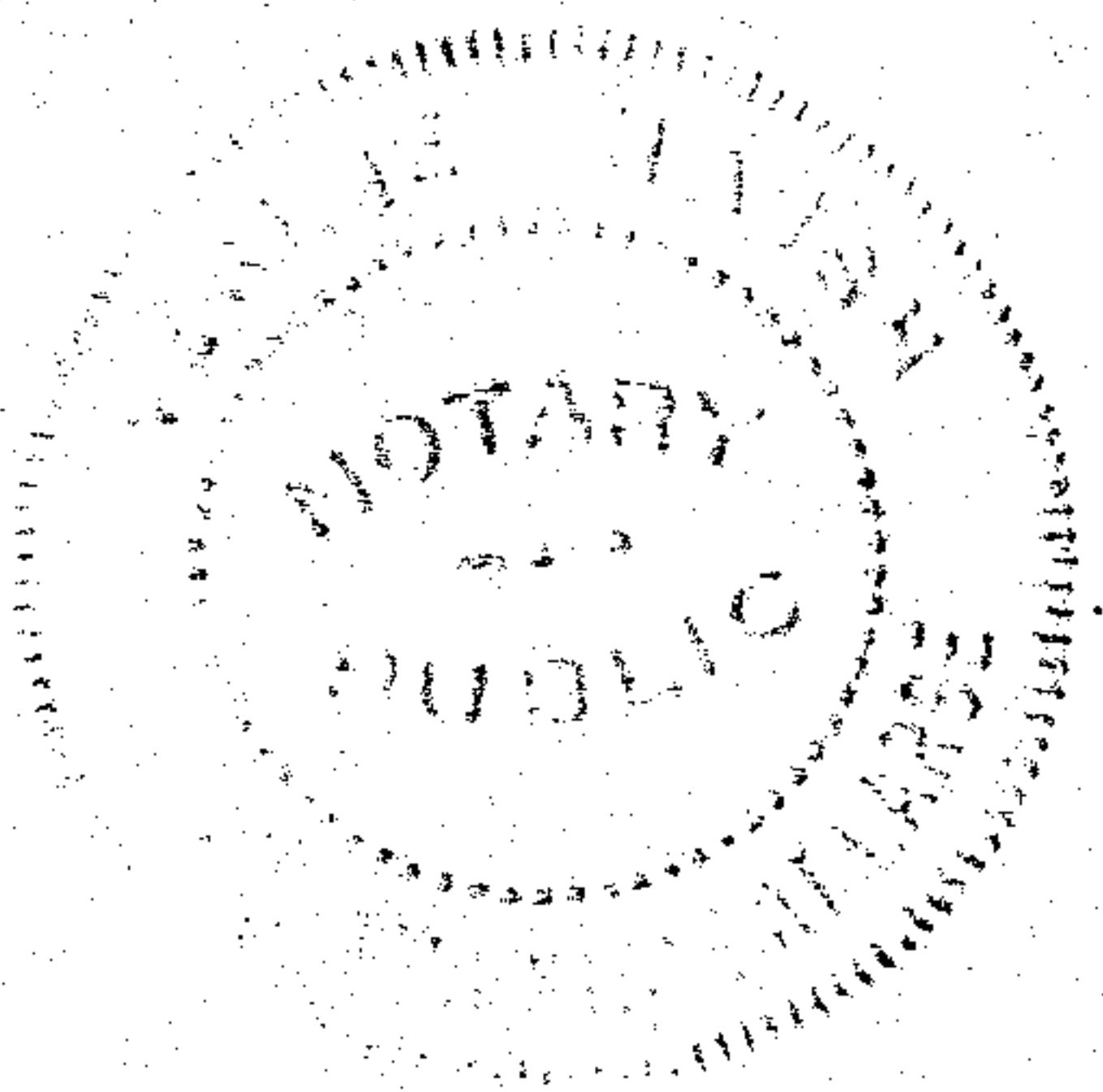
