convey unto George F. Parr and George Christopher Parr  
(herein referred to as grantee, whether one or more), the following described  
real estate, situated in Shelby County, Alabama, to-wit:

A parcel of land situated in the NW $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 7, Township 22  
South, Range 2 West, described as follows: Beginning at the Southwest  
corner of the NW $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 7, go North 5 deg. 38 min. East  
along the West boundary of said  $\frac{1}{4} \times \frac{1}{4}$  section 391.04 feet; thence North  
73 deg. 23 min. East for 571.44 feet; thence South 62 deg. 45 min. East  
for 22.30 feet to a point on a curve to the left on the West boundary of  
Woodland Drive, said curve having a central angle of 213 deg. 40 min.  
and a radius of 60.00 feet; thence along this curve 223.74 feet; thence  
North 83 deg. 35 min. East along the South Boundary of Woodland Drive  
for 140.00 feet; thence South 6 deg. 23 min. East for 631.40 feet; thence  
North 81 deg. 30 min. West for 951.33 feet to the point of beginning.

All corners are marked by irons and tract contains 10.58 acres. ALSO

86 deg. 18 min. West for 497.73 feet to a point on a curve on the East  
boundary of Meadowood Lane, said curve having a central angle of 60 deg.

curve 63.58 feet; thence North 45 deg. 34 min. East for 824.00 feet
