JOHN B. SMITH/JR. and wife, WANDA LYNN SMITH

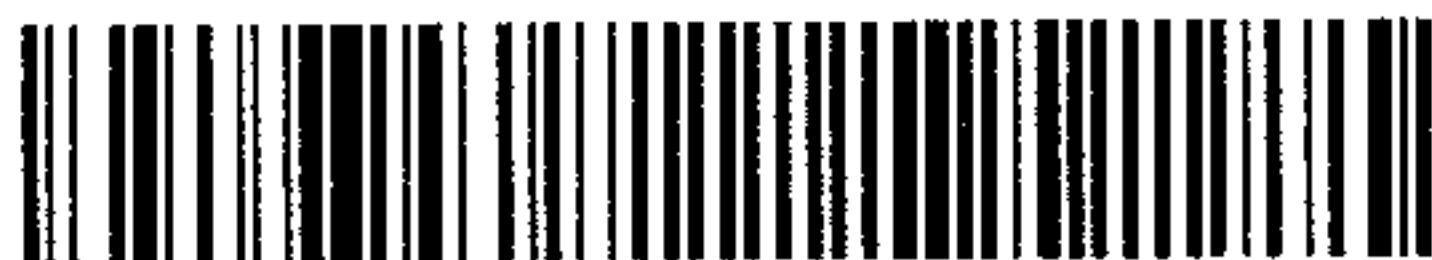
