FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS:

THAT, WHEREAS, default having been made in the payment of the indebtedness due by that promissory note and real estate mortgage securing payment of the same, executed by GENERAL LEE AGEE and wife, BOBBIE ANN AGEE, to MERCHANTS & PLANTERS BANK, MONTEVALLO, ALABAMA, a corporation, and recorded in Mortgage Book 329, page 882, in the Probate Records of Shelby County, Alabama, which mortgage described the real estate hereinafter set out; and

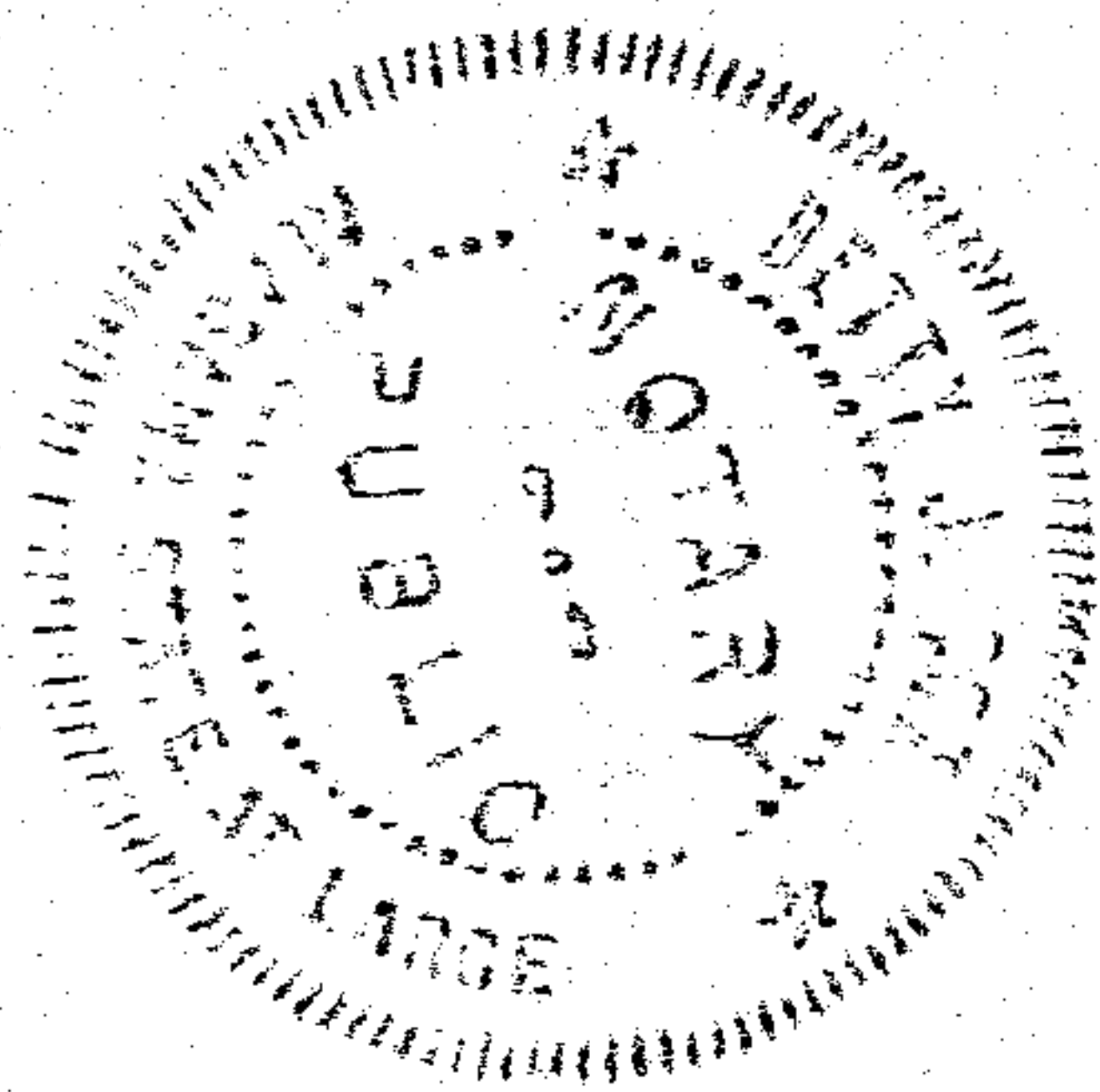
