KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of Two Thousand Two Hundred and no/100 Dollars, to the undersigned grantors, W.W. Donaldson and wife, Maude Donaldson, in hand paid by Kimberly-Clark Corporation, the receipt whereof is hereby acknowledged, we, the said W.W. Donaldson and wife, Maude Donaldson, do hereby grant, bargain, sell and convey unto the said Kimberly-Clark Corporation, all of the merchantable pine located on the following property:

NW $\frac{1}{4}$  of SE $\frac{1}{4}$ ; SW $\frac{1}{4}$  of SE $\frac{1}{4}$  north of Camp Branch; Section 5 Township 22 South, Range 1 West, Shelby County, Alabama.

together with full and free right of ingress and egress to and from said land at any and all times until the expiration of twelve (12) months from the date of the execution of this deed, for the purpose of cutting and removing said timber, but after said time, grantee shall have no further rights or interest in said land or timber and at the expiration of said time, said land and all uncut timber shall revert to the grantors herein.

The grantee is hereby given the right to use existing private roads and has the right to build such temporary roads and other devices as may be necessary or useful to the grantee for the purpose of cutting and removing the timber.


