WITNESS, For and in Consideration of the sum of ONE DOLLAR (\$1.00) in hand paid to B. F. Hatchett and Dorothy Hatchett (hereinafter referred to as Grantors) by South Central Bell Telephone Company (hereinafter referred to as Grantees) the receipt of which is hereby acknowledged, the Grantors do hereby grant permission to Grantees to install and maintain the two existing cables now installed by Grantees over Grantors property as shown on Exhibit "A" attached hereto and made a part and parcel hereof as fully as if set out herein.

It is further agreed that if at any time in the future the Grantees desire to place any additional telephone cables on the described property or remove any cables therefrom, they will do so after giving Grantors thirty (30) days advance notice and upon receiving no protest from said Grantors. This procedure will be followed for any and all proposed subsequent installation of any type of telephone plant.

It is understood and agreed that if at any future time it is necessary to excavate and repair either of the two existing cables for maintenance reasons, (Maintenance being defined as repair of any damage caused by other persons or acts of God, such damage being of such an extent that subscribers are either without telephone service or likely to be without service), Grantors waive the necessity for Grantees giving advance notification to Grantors.

383 It is further understood and agreed that Grantees will not in any way interfere with present drainage of surface water across said property or any part thereof and Grantees will repair any damage done to the pavement, sidewalk, or surface of said property.

In consideration of the benefits to be received and of other good and valuable consideration received from South Central Bell Telephone Company, (I) (We) hereby grant said Company, its associated and allied companies, their respective licensees, successors and assigns, the right to construct, operate and maintain, ~~and/or~~ lines or systems of communications consisting of ~~and~~ buried cables and wires, ~~cable terminals, markers, splicing boxes and pedestals, conduits, manholes, underground cables and wires and any other equipment, boxes, appurtenances or devices as may be required upon, across, over and/or under~~ that certain tract of land situated in Shelby County, State of Alabama, to-wit: A lot as identified on sketch located in Section 25, Township 21S, Range 1W, right-of-way to extend from the north side of right-of-way of Ala. Highway 25 northward to the southside of existing sidewalk.

and, to the fullest extent the undersigned has the power to grant, if at all, upon, along, and under the roads, streets or highways adjoining or through said property, with the right to permit the attachment of, and/or carry in conduit or trenches, wires and cables of any other person or company for communication purposes or for the transmission and distribution of electric power, and the right of ingress and egress to said premises at all times for the purpose of inspecting and maintaining said line, and with the right to clear and keep cleared all trees, undergrowth or other obstructions within a strip of land 25 feet on each side of the center of said line, and to trim and cut and keep trimmed and cut off dead, weak, leaning or dangerous trees which might reach said line in falling, including the right to relocate said line on said premises to conform to any future highway relocation, widening or improvement.
