described real estate, situated in Shelby County, Alabama, to-wit:

All that part of the NW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 28, Township 19, Range 1 East, lying south of the Atlantic Coast Line Railroad right-of-way.
ALSO, commence at the southwest corner of the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 28, Township 19, Range 1 East and run thence east to the west right-of-way line of the Columbiana-Westover paved road; thence run in a northerly direction along said west right-of-way line of said road to a point 50 feet south of the intersection of said road with the south R/O/W line of A.C.L.
