(herein referred to as grantors) do grant, bargain, sell and convey unto

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

From the SE corner of the NW 1/4 of the NE 1/4, Section 7, Township 21 South, Range 2 East, run west along the south boundary of said 1/4-1/4 a distance of 87.29 feet; thence, right 79 deg 39' a distance of 766.79 feet; thence, left 87 deg 53' a distance of 224.09 feet to the point of beginning; thence, right 90 deg 00' a distance of 200.00 feet; thence, left 95 deg 45' a distance of 174.95 feet; thence, left 7 deg 26' a distance of 70.66 feet; thence, left 46 deg 18' a distance of 80.68 feet; thence, left 7 deg 50' a distance of 104.65 feet; thence, left 112 deg 31' a distance of 324.31 feet to the point of beginning.

There is also conveyed to grantee, his heirs, successors, and assigns the right to use the present boat launching site of grantor on Lay Lake for the purpose of launching boats for their private use, together with the right to fish from the bank of Lay Lake on property now owned by grantor.
