KNOW ALL MEN BY THESE PRESENTS:

That for and in consideration of the love and affection which I, the undersigned Homer M. Whitfield (also known as Homer Whitfield and H. M. Whitfield), bear for my daughter, Edna W. Ball, and in consideration of the sum of One Dollars (\$1.00) to me in hand paid by Edna W. Ball, the receipt of which is hereby acknowledged, I, the said Homer M. Whitfield, an unmarried man, hereby give, grant, bargain, sell and convey unto my said daughter, Edna W. Ball, the following described real estate in the SE-1/4 of the NE-1/4 of Section 12, Township 18 South, Range 1 East, Shelby County, Alabama, containing 5 acres, viz:

Beginning at the Northwest corner of said Southeast Quarter of Northeast Quarter run South along the West line of said 40 acre tract a distance of 428.20 feet to the point of beginning of the parcel of land hereby conveyed, thence continue along said West line of said Southeast Quarter of Northeast Quarter a distance of 662.46 feet, more or less, to the North right-of-way line of Shelby County Highway No. 43, thence turning to the left run along said North right-of-way line of said highway 409.15 feet, thence turning an angle to the left of 61 degrees 26 minutes run North and parallel to said West line of said Southeast Quarter of Northeast Quarter a distance of 491.76 feet, thence turning to the left so as to include an angle of 89 degrees 58 minutes 30 seconds run a distance of 371.83 feet to the point of beginning of the parcel hereby conveyed together with all improvements located on said parcel, but reserving and excepting to the grantor a life estate in and to said property.
