WHEREAS, on the 5th day of April 1971, a decree was rendered by the Probate Court of said County for the sale of the lands hereinafter described and conveyed for the State and County taxes then due from Charles H. Raines and

lying and being situate in said County and State, to have and to hold the same, the said rights, titles and interests unto himself the said Mrs. George D. Pamplin and his heirs and assigns forever, but no right, title or interest of any reversioner or remainderman in said land is conveyed hereby.
